Catholic Authors and Publishers Continue to Hire Credibly Accused Former Priest Barry M. Hudock

<u>James Faluszczak</u>, himself a victim of abuse by a priest, and still feeling called to the priesthood, left active ministry because the Church ignored his claims. He testified before the <u>40th Pennsylvania Grand Jury</u> as it investigated six dioceses in Pennsylvania.

ALBANY, MN. Tuesday, May 9, 2023 – 2020 Catholic Press Association awardee <u>Barry Michael Hudock</u> continues to win accolades and work <u>after resigning</u> from Liturgical Press (Collegeville MN) following the <u>2018 Pennsylvania Grand Jury</u>. His hiring there followed his 2009 termination by Syracuse NY Christian Brothers Academy for the same allegation. His work today benefits Liturgical Press and other Catholic publishers.

Among several current clients, former Diocese of Albany NY communications director <u>Mary DeTurris-Poust</u>, Villanova University theology professor <u>Massimo Faggioli</u>, and composer and Little Portion Hermitage founder <u>John Michael Talbot</u> are <u>self-listed by Hudock as</u> clients.

Hudock has been judged by the Diocese of Erie as <u>ineligible to work with children</u>, but he is apparently permitted to write, edit, and contribute to the publishing of Catholic theological works. Among his clients are those who write about the abuse crisis and assist bishops with its management.

Taking note of the <u>playbook</u> of bishops who sanitize and transfer abuser-priests, Catholic authors and publishing houses are able to keep wayward editors and authors in the fold through arms-length associations which remain mutually beneficial. That such a mechanism is used today to teach the faith, should instead represent an obstacle to faith.
